To whom it may concern

Dear all,

Ministry of infrastructure of Ukraine is informing you that due to the military aggression of the Russian Federation against Ukraine, according to the Decree of the President of Ukraine of February 24, 2022 № 64/2022, the martial law was imposed in Ukraine from 05:30 on February 24, 2022 for 30 days.

In view of the above, container handling in Ukrainian seaports, as well as the handling of container ships, is practically impossible.

According to available information, the operators of line transportation began to accrue demurrage for storage of containers that were sent to Ukraine before the imposition of martial law, both in transshipment ports and in Ukrainian ports.

Considering the difficulties faced by the state of Ukraine until the end of martial law, we kindly ask you not to apply demurrage for storage of containers both in transshipment ports and in Ukrainian ports.

The Ukrainian Chamber of Commerce and Industry (hereinafter - CCI of Ukraine) on the basis of Art. 14, 14<sup>1</sup> of the Law of Ukraine "On Chambers of Commerce and Industry of Ukraine" of 02.12.1997 № 671/97-VR, the Statute of the CCI of Ukraine, evidenced force majeure circumstances: military aggression of the Russian Federation against Ukraine.
